

MINUTES OF THE BERE REGIS PARISH COUNCIL HELD ON THURSDAY 10th JANUARY 2019 AT THE BERE REGIS SPORTS CLUB, NORTH STREET, BERE REGIS, COMMENCING 7PM

Public Participation

18.218 No members of the public were present but Cllr Benjafield and received a request from Mr Michael Wooten, which he read out to the meeting:

Mr Wooten highlighted the issues of the 'park and ride' outside his property in North Street, opposite the Shell Garage. The imposition of yellow lines will be raised at the February meeting and nearby residents will be contacted to see if they are in favour of such action. Cllr Benjafield will speak to Mr Wooten again.

Cllr Pitcher reported that he had been approached by Mr Banyard regarding his response to the Neighbourhood Plan consultation.

The issue of a possible wooded area between housing and any industrial development was also raised. It was noted that there will be a SANG behind the proposed industrial area.

To receive apologies for absence 1.

18.219 Apologies have been received from Cllrs Philip Morgan, Brenda House and Tony Bates, and the Clerk, Amanda Crocker.

18.220 A copy of the minutes had been issued to all members prior to the start of the meeting. Cllr Benjafield proposed them to be a true and accurate representation of the meeting. This was seconded by Cllr Munnings and agreed unanimously. The Chair signed the minutes in the presence of the meeting.

Matters arising from those minutes, not covered by this agenda

18.221 Christmas trees - how many were sold? Post meeting note: Only 30 trees were sold although several villagers ordered trees without paying and then never collected. The number of trees ordered was reduced from 80 in 2017 to 50 in 2018.

Cllr Packham asked if it would be possible for the school to have a tree in 2019. This can be discussed at the appropriate time.

Tillhill – Cllr Ventham will approach Brian May direct with regard to the footpath extension.

There are currently four volunteers who are willing to drive the vehicle. DCC will carry out all appropriate checks and have agreed to undertake annual services and maintenance at a cost of £360p.a.

Both the Scouts and the Sports Club have expressed an interest in hiring the bus.

The Clerk will check on any potential change in legislation requiring formal minibus training for all drivers.
